# **About MZB Standard Enterprise**

its subsidiaries, assignees, affiliates, successors, as well as any company which controls MZB Standard Enterprise directly or indirectly.

# **Your Representations**

You represent and guarantee that you have the adequate legal capacity to enter into this Agreement. You represent that in the framework of this Agreement you are an independent contractor acting on your own risk with your own funds and counting on benefits which may not meet your expectations. You further represent and guarantee that you will act for lawful purposes only and use only lawful

methods in accordance with this Agreement or any operating law.

You further represent and guarantee that your only purpose to enter into this Agreement is to receive a reward if a buyer of  $LookupPal^{TM}$  license pays for the purchase, does not request a refund in a reasonable period, and uses your independent contractor identification number correctly and appropriately when registering as an end user of  $LookupPal^{TM}$ .

#### Translation

The original text of the Agreement is in English. The text of this Agreement, explanatory texts, and texts of terms and conditions may exist in different languages. You know and agree that any non-English text within this Agreement regarding *LookupPal*<sup>TM</sup> or MZB Standard Enterprise or connected with *LookupPal*<sup>TM</sup> or MZB Standard Enterprise is a translation of the original English text and is provided for convenience only.

The translated text may be incomplete or inaccurate.

MZB Standard Enterprise does not guarantee accuracy, correctness, or completeness of the translation. To the extent of any inconsistency between the translated text and the original English text, the English text shall prevail.

#### **Entry into Agreement by Parties**

The parties enter into the Agreement by an electronic communication exchange. The independent contractor's electronic communication shall be registering as an independent contractor on a special page of a personal account, located on the electronic resources of MZB Standard Enterprise. MZB

Standard Enterprise's electronic communication shall be emailing an independent contractor its confirmation of entering into the Agreement, along with an assigned unique independent contractor identification number ("MZB Standard Enterprise identification number" or "identification number"), and the text of this Agreement.

Registration. To be able to enter into the Agreement and fulfill your part of the Agreement properly, you and third parties shall use certain MZB Standard Enterprise Services. To fulfill the Agreement, MZB Standard Enterprise requires, and you agree, that you shall acquire a *LookupPal*<sup>TM</sup> license, register as an end user of MZB Standard Enterprise Services, enter into this Agreement, register as an independent contractor, and provide information about you as an end user of these Services and an independent contractor including, without limitation, a name and an email address.

Moreover, you shall be solely responsible for all potential claims connected with sending messages to third parties.

MZB Standard Enterprise controls in no way your business connections relating to a third-party, and MZB Standard Enterprise shall not be responsible for your actions, improper and/or untimely actions or inaction.

#### Reward

Your reward shall be 0.6 US dollars for each sold license of the computer program *LookupPal*<sup>TM</sup>. These 0.6 dollars constitute 40% of a special price (1.5 US dollars) for the license of the computer program *LookupPal*<sup>TM</sup>, paid by a buyer upon entering an independent contractor identification number.

MZB Standard Enterprise expects that when registering, some buyers of *LookupPal*<sup>TM</sup> licenses correctly and appropriately enter your identification number into a special window that MZB Standard Enterprise shall interpret as your implementation of activities leading to a sale of *LookupPal*<sup>TM</sup> license to a buyer who has entered your identification number into a special window when registering as an end user.

For MZB Standard Enterprise, entering your identification number into a special window when registering shall be the first, but not the only, condition to issue you the mentioned reward. The second condition to issue you the mentioned reward shall be a payment in full to MZB Standard Enterprise of a special price for *LookupPal*<sup>TM</sup> license and absence of refund requests within 17 days by the same buyer of *LookupPal*<sup>TM</sup> license.

After implementation of both conditions you shall be issued a reward upon your request.

# **Privacy Policy**

This Privacy Policy shall govern your use of MZB Standard Enterprise Services (see below for definition). MZB Standard Enterprise shall also assign a unique independent contractor identification number to each independent contractor. Feel free to share this independent contractor identification number. Upon entering this number into special windows in different cases, MZB Standard Enterprise identifies a connection of an independent contractor with events entailing consequences, including payment to an independent contractor, whose identification number has been used.

# Our Security Liability

MZB Standard Enterprise takes appropriate security measures to protect data about you received by MZB Standard Enterprise Services from unauthorized access or use.

The agreement shall be valid for three hundred and sixty days, including days on which each of the parties enters into the Agreement. Each day shall be counted by Toronto (Ontario, Canada) time, starting from the first minute after midnight.

The agreement shall not be renewed automatically.

Upon the expiration of the Agreement and a wish of an independent contractor to extend activities of promoting *LookupPal*<sup>TM</sup>, the parties shall enter into a new Agreement.

The provisions of this Agreement regarding the obligations to pay money shall survive the termination of this Agreement until the obligations are fulfilled in full.

#### Support

You understand that you use MZB Standard Enterprise Services at your own risk, and that the MZB Standard Enterprise company does not provide any support, except for the information posted at the MZB Standard Enterprise company website at <a href="http://LookupPal.com">http://LookupPal.com</a>.

# **Changes to Agreement**

You agree that the provisions of this Agreement shall remain unchanged for the entire term of validity of this Agreement. You agree that to change the terms of cooperation of the parties, it shall be necessary and sufficient to enter into a new Agreement.

#### **Electronic Notifications**
